

Registration Instructions

You will need to provide information on the following items in order to complete registration:

- Individual license number(s)
- 2. Federal tax identification (FEIN), business or social security number (SSN)
- 3. Agency license number(s)
- 4. Errors & Omissions Policy information

Step 1: Begin at usassure.com

Hover over Agents on right of the top navigation menu and then select **Become an Agent** from the drop-down menu.




Step 2: Complete the Online Form


Step 2: Business Information

Is your agency already registered?

Note: Zurich appointed agents are not required to include this information.



Select the appropriate answers about your company and the business you service. When finished, press **Submit.**




Step 3: Accept the User Agreement
